ARTICLES OF INCORPORATION BAY HIGH SCHOOL GIRLS SOFTBALL BOOSTER CLUB, INC.

The undersigned subscribers to these Articles of Incorporation hereby subscribe to and corporation not for profit under the laws of the State of Florida.

ARTICLE I – NAME

The name of this corporation is BAY HIGH SCHOOL GIRLS SOFTBALL BOOSTER form a corporation not for profit under the laws of the State of Florida.

CLUB, INC.

ARTICLE II – PURPOSES AND POWERS

- 1. The principal place of business and mailing address of this corporation shall be 6001 Jammie Road, Youngstown, Florida 32466. This corporation is organized and incorporated for the purpose of supporting and promoting the Bay High School (Panama City, Florida) Girls' softball program.
- 2. The corporation shall have such powers as are provided under Florida law pursuant to Chapter 617, Florida Statutes, for corporations not for profit.
- 3. No part of the net earnings of this corporation shall inure to the benefit of any private shareholder or individual, and the corporation shall make no distribution of income to its members or officers.
- 4. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

5. Notwithstanding any other provisions of these articles, the corporation shall not carry on any activities not permitted to be carried on by the following:

- a. a corporation exempt from Federal Income Tax under the Internal Revenue

 Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law)

 or;
- b. a corporation, contributions to which are deductible under the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE III – DURATION

- 1. This corporation shall have perpetual existence and shall commence on filing of these articles.
- 2. In the event of dissolution of the corporation, the officers, after paying or making provisions for the payment of all the liabilities of the corporation, shall dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as exempt organizations under the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the officers shall determine. Any such asset no so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as the court shall determine, which are organized and operated for such purposes.

ARTICLE IV MEMBERSHIP

Any person, firm, corporation, partnership or other business entity interested in the support and promotion of Bay High School Girls' softball is eligible for membership in this corporation.

ARTICLE V - INCORPORATORS AND SUBSCRIBERS AND DIRECTORS

This Corporation shall have three directors initially. The names of the initial directors are: Gregory T. Hunsicker, Ed Snipes and Elisa Hunsicker. The number of directors may be either increased or diminished from time to time by the By-Laws but shall never be less than three. 
