ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

FBO/CBO CONSORTIUM OF BROWARD COUNTY, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, Promayart Foundation, Inc., a Florida not for profit corporation, document number N03000001143 (the "Corporation") adopts the following articles of amendment to its Articles of Incorporation.

FIRST: A new Article XIII should be added to the Corporation's Articles of Incorporation to read as follows:

ARTICLE XIII Dissolution

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state of local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is located, exclusively for such purposes or to such corporation or corporations, as said Court shall determine, which are organized and operated exclusively for such purposes.

SECOND: The amendment was adopted on November /2, 2003.

THIRD: There are no members entitled to vote on the amendment. The amendment was adopted by the board of directors.
