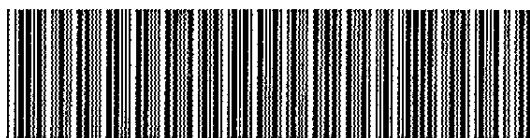

Articles of Incorporation of New Harvest Urban Ministries, Inc., who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida.

Article I

The name of the Corporation shall be New Harvest Urban Ministries, Inc.

Article II

The initial place in Florida where the principal office of the Corporation is to be located is 3911-B NW 13th Street, Gainesville, Florida 32609, in Alachua County. The Board may choose to relocate the principal office to another site within Alachua County at its discretion.

Article III

Said corporation is organized as a church for the purpose of proclaiming the gospel of Jesus Christ to Gainesville and all the earth. New Harvest Urban Ministries, Inc. will achieve our purpose by exalting Christ, evangelizing the lost, encouraging the hurting, enriching the community and equipping believers.

Article IV

The business affairs of New Harvest Urban Ministries, Inc. shall be managed by its Officers, which may exercise all corporate powers not specifically prohibited by statute or by the certificate of incorporation. Members of the Board/Officers are appointed at the January meeting by the Church Pastor and will serve on a voluntary basis for a one year term.

Article V

Officers and terms of New Harvest Urban Ministries, Inc.

The Officers shall consist of President, Vice President, Secretary and Treasurer. Officers shall be appointed by the Pastor for a term of one year, which will run from January through December. All officers may serve for consecutive years. The names and addresses of the initial officers are:

Vice-President: Terrence J. Brannan, 13106 NW 19th Place, Gainesville, FL 32606.;

Secretary: Karen Johnson, 730 SE 8th Street, Gainesville, FL 32601.

Article VI

The initial registered agent for New Harvest Urban Ministries, Inc. will be Pastor Grant D. Smith, 6284 SW 8th Place, Gainesville, FL 32607.

Article VII

The incorporator for New Harvest Urban Ministries, Inc. will be Pastor Grant D. Smith, 6284 SW 8th Place, Gainesville, FL 32607.
