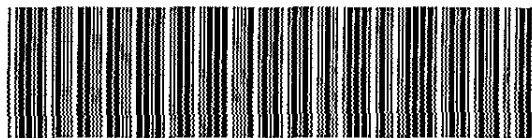

The undersigned, acting as incorporator of a corporation pursuant to the Florida Not For Profit Corporation Act, chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

1. NAME

The name of the Corporation is:

MARCUS CHRISTIAN ACADEMY, INC.

2. TERM OF EXISTENCE

The date when the corporate existence shall commence shall be January 31, 2003, and the Corporation shall have perpetual existence thereafter.

3. PURPOSE

The purpose for which the Corporation is organized is to transact any and all business for which a corporation may be incorporated under the "Florida Not For Profit Corporation Act", Florida Statutes 617.01011, et seq., including, but not limited to the following:

a) Such religious, charitable, scientific, literary and educational purposes as will qualify the Corporation as an exempt corporation within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

b) Notwithstanding any other provisions of these Articles of Incorporation, this organization shall not carry on any activities not permitted to be carried on by a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or b) a corporation, contributions to which are deductible under §170(c)(2) of the Internal revenue Code of 1986 or any other corresponding provision of any future United States internal revenue law.

4. APPOINTMENT/ELECTION OF DIRECTORS

The method of appointing and/or electing members of the board of directors shall be as stated in the bylaws of the Corporation. The number of directors shall in no case be less than three.

5. REGISTER AGENT AND OFFICE PRINCIPAL OFFICE AND ADDRESS

The registered agent of the Corporation shall be Kristopher E. Fernandez, Esquire.



6. INCORPORATOR


