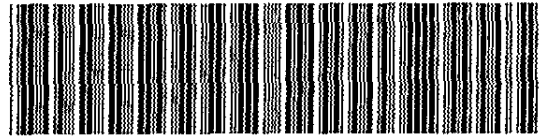

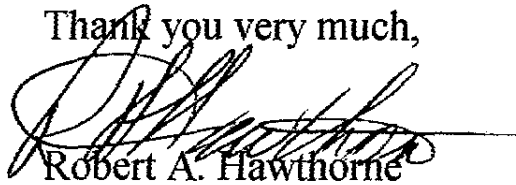

ARTICLES OF INCORPORATION  
FOR  
**CHRISTIAN PARTNERS OF HOPE, INC.**

Pursuant to Chapter 617, Florida Statutes of the Florida Business Corporation Act, the undersigned Incorporator submits these Articles of Incorporation for the purpose of forming a Not-For-Profit Corporation.

ARTICLE I – NAME:

The name of the corporation shall be: **Christian Partners of Hope, Inc.**

ARTICLE II – PRINCIPLE OFFICE:

ARTICLE III – PURPOSE:

The purpose for which the corporation is organized is for the purpose of dissemination of the Christian beliefs, both local and national, to engage in all kinds of home and foreign missionary work, to license and ordain elders, teachers, ministers and evangelists; thereby giving, granting and bestowing upon them ecclesiastical power, privilege and authority as Christian Clergymen to engage in any church related activities to help spread the gospel, including but not limited to, the establishing of churches.

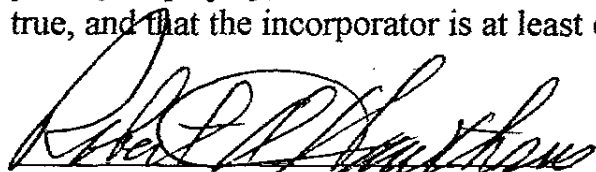

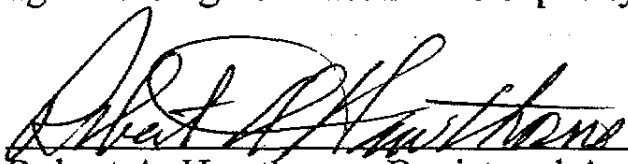
