**Articles of Incorporation:**

- Article I: The name of the corporation is Saint Barbara's Carpatho Russian Orthodox Church, Incorporated..
- Article II: The principle place of services, is St. Joseph's Roman Catholic Church, 1402 Miller Street, Palm Bay, Florida, the mailing address is the church rectory, 302 San Filippo Dr. SE, Palm Bay Florida.
- Article III: The corporation is organized for the worship of Almighty God and His Son, our Lord Jesus Christ. For spiritual well being of the parishioners, including Divine Services, and administration of the Sacraments according to the Canons of the Orthodox Church. The Church derives its ecclesiastic authority to function from the ruling Bishop of the American Carpatho Russian Orthodox Greek Catholic Diocese of the USA headquarters in Johnstown, Pennsylvania.
- Article IV: The pastor, being assigned by the Ruling Diocesan Bishop is the Director of the Corporation, the other members of the governing board be Orthodox Christians, consisting of the Secretary, Treasurer, and three (3) trustees that shall be elected into office at a semi-annual meeting convened in January of each year.


