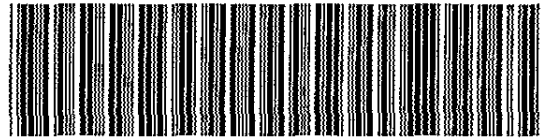

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

Article VIII Initial Registered Agent and Street Address




