The Articles of Incorporation of Angels Working 4 Jesus, Inc.

Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Non-profit Corporation Law of Chapter 617, Florida Statutes, do hereby certify:

Article One: The name of the Corporation shall be **Angels Working 4 Jesus, Inc.**

Article Two: The place in this state where the principal office of the Corporation is to be located is 4900 Bottlebrush Lane # 112 Orlando, FL 32808

Article Three: The purpose of this corporation will be to train students in the area of business and finance empowering them to become accountable through biblical & academic development, positive environment and recreation.

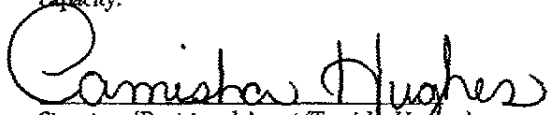

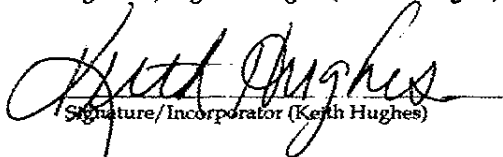
