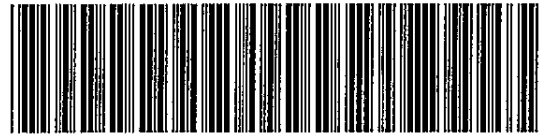

ARTICLES OF INCORPORATION  
BLUE ANGEL SERVICE DOGS, INC.

We the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the not for profit corporation laws of the State of Florida, Section 617.013 of the Florida Statutes, we hereby make, execute and adopt the following Articles of Incorporation:

**ARTICLE I NAME**

The name of the corporation shall be BLUE ANGEL SERVICE DOGS, INC.

**ARTICLE II PRINCIPLE OFFICE**

The principle place of business and mailing address of this corporation shall be:

**ARTICLE III PURPOSE**

The purpose for which this corporation is organized exclusively for, and will be operated exclusively for educational and charitable purposes including, but not limited to, the purpose of training animals for service in the medical field, disabled persons, and any other organization requiring trained service animals. Notwithstanding any other provision of these articles, this corporation shall not carry on any activities not permitted by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

This service will be available world wide.

**ARTICLE V MANNER OF ELECTION**

The officers of the corporation will elect the board of directors.

**ARTICLE VI NET EARNINGS/COMPENSATION**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

**ARTICLE VII DISSOLUTION OF CORPORATION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
