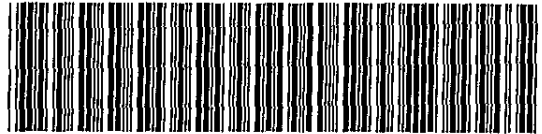

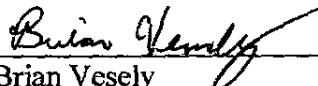

**ARTICLES OF INCORPORATION
FOR
CLO VESELY FOUNDATION, INC.**

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a non-profit Corporation under the Non-Profit Corporation Law of Florida, Fla. Statutes Chapter 617, do hereby certify:

Article I

The name of the corporation shall be **CLO VESELY FOUNDATION, INC.**

Article II

The place in this state where the principal office of the Corporation is to be located is the City of Tampa, County of Hillsborough, State of Florida.

The address where the principal office of the corporation is to be located is:

5020 Londonderry Drive

Tampa, Florida 33647

Article III

Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including; for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

Article IV

The Directors shall be appointed yearly by the initial Directors or their heirs or assigns to the corporation.

Article V

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal revenue Code, or any corresponding future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, engage in any activities or exercise any powers that are not in furtherance of the purposes of this cooperation.

Article VI

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 c3 of the internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a states or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

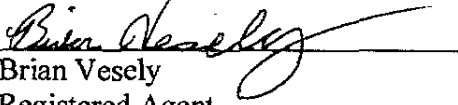

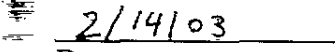

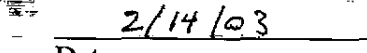
