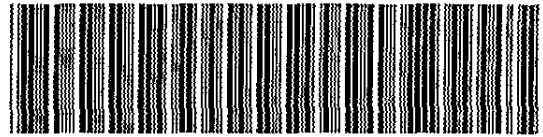

**ARTICLES OF INCORPORATION OF  
CHRISTIAN LIFE ASSEMBLY OF GOD, INC.**

This is a not for profit corporation formed in compliance with Chapter 617.01 of the Florida Statutes, and with the Internal Revenue Service Code Section 501( c)( 3).

**ARTICLE I: NAME**

The name of this corporation is Christian Life Assembly of God, Inc.

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
9641 SW Highway 484; Ocala, Florida 34481.

**ARTICLE III: PURPOSE**

The general purpose of this corporation shall be to acquire, establish and maintain all necessary properties and buildings for religious worship, church school, evangelistic meetings, missionary activities, and all other necessary business pursued by churches of the evangelical faith; and to conduct religious services, church school, evangelistic meetings, missionary activities, and all such activities which in general promote the spiritual, physical, and material welfare of the church membership and the Ocala, Florida area.

To fulfill these purposes, this corporation will transact the following types of activities:

1. To engage in educational and training endeavors which will promote the spiritual, physical, and material welfare of others and which enhances a Godly life-style.
2. To conduct business, have one or more offices, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property in the State of Florida for the purpose of promoting the religious activities of the church.
3. To contract debts and borrow money, issue and sell or pledge bonds, notes, and other evidence of indebtedness, and execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as the law requires.
4. The avoidance of any political propaganda or activity.

**ARTICLE IV: MANNER OF ELECTION AND INITIAL DIRECTORS/OFFICERS**

The affairs of the corporation are to be managed by the Church Board who are to be elected by the membership of the church. The membership of the church shall also elect the

Church Officers who will be designated as President, Church Secretary, and Church Treasurer.

These Articles of Incorporation may be amended by a majority vote of the directors of this corporation.

### ARTICLE X: DISTRIBUTION OF ASSETS UPON DISSOLUTION

No person, firm, or corporation shall ever receive any dividends or profits from the undertaking of this corporation, and upon dissolution of this organization, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to an organization or organizations which have qualified for exemption under Section 501 (c) (3) of the Internal Revenue Code, or to the Federal Government, or to a State or local government, for a public purpose, and none of the assets will be distributed to any member or officer of this corporation.
