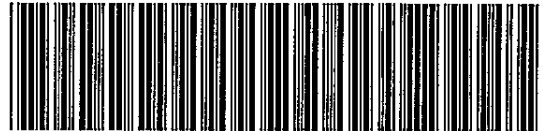

**ARTICLES OF INCORPORATION  
OF  
SMART KIDS – SAFE KIDS, INC.**

**(A Not for Profit Corporation under Chapter 617, Florida Statutes)**

**ARTICLE I - NAME**

The name of this Corporation is: Smart Kids – Safe Kids, Inc.

**ARTICLE II - DURATION**

The duration of the Corporation shall be perpetual.

**ARTICLE III - PURPOSE**

The Corporation is formed for the following purposes: To engage in the non-profit transaction of all lawful business for which non-profit corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

The Corporation shall not engage in any action prohibited by the Florida Not for Profit Corporation Act or by the Internal Revenue Code and no part of the net earnings shall inure to benefit or be distributed to its members, directors or officers. However, the Corporation may pay reasonable compensation to any member, director, or officer for reasonable services.

**ARTICLE IV - NON-STOCK BASIS**

The Corporation is organized and shall be operated on a non-stock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock. The Corporation may issue membership certificates as provided in the corporate bylaws.


