

Jones** become duly appointed acting President and Registered agent and to take on all legal representation and day to day affairs of the business of the above said Organization.

The first Special Called Meeting of the Incorporators was held on <u>November 7, 2021</u>, which was the First Sunday of April according to <u>Articles XIII</u>. <u>Distribution of Assets upon Dissolution of the Articles of Incorporation Board of Directors</u>. The meeting was held in <u>Ft Lauderdale</u> in the <u>State of Florida County of Broward</u>.

Andrew J Jones. A subscriber to the Certificate of Incorporation called the meeting to order and stated the purpose of this meeting was because of the urgent need to reinstate corporation. That the acting secretary failed to comply. And now the Gateway Community Outreach Church, Inc. has been dissolved.

The Meeting was called to order by acting Chairperson who explained that we the Board of Directors shall now consist of only 3 Initial Directors. And these Board of Directors be responsible for the maintenance of cohesiveness within the corporation and its members as well as the maintenance of membership standards. And after due examination we the Board have consent with unanimous vote that Melissa McLane and Teresa McLane no longer fulfills the requirements for membership, and that their membership shall be terminated effective immediately, and any decision of this Board of Director be final and not subject to appeal to any higher ministry or other body or law.

The Executive Director/ Registered Agent on November 14, 2021, change the name on articles to reflect the new administration, to reinstate the Corporation, and to limit the Board of Directors to only 3 Directors. On February 25, 2022 Melissa Mclane having no <u>supreme executive, legislative and judicial authority</u> and was not even recognized as a Board Member submitted false information in a document to the Department of State by naming herself as the Executive Director, Also changed the President of over 21 years Rosa Mclane placing her as Advisor, and then proceeded to place her Sister Teresa Mclane as Vice President, and Aunt Shirley Lee as Treasure, and Toru A Dean Sr. as Advisor. According to the Articles of Gateway Community Outreach Church, Inc. according to Article V - section C Only the authorized representatives of the Board of Directors can constitute these Changing. At the time of these changes none of theses individuals was active Board Members except Rosa Mclane who also was not in the knowledge of these changes and no Board meeting was ever held. Please be aware we stipulate that the allegations in the Information and the following facts are true and correct. And that False information have been submitted to the Department of State by Melissa Mclane and that this constitutes a third-degree felony as provided in s.817.155, F.S. and we are seeking further actions on the full extent of the law on behalf of our organization.
