ARTICLE - XV11 AMENDMENT OF ARTICLES

Section 1 Type; - The EPISCOPAL type in the Episcopal form of organization is thoroughly controlled by an Apostle, Bishop, or General Overseer that singly rules over the entire ecclesiastical organization of the Church. The Apostle, Bishop, or General Overseer has legislative powers over the denominational body and is above local churches in rank and authority. They hold all properties in trust and make all Ministerial appointments. This organization named GATEWAY COMMUNITY OUTREACH CHURCH, INC is the unit of the EPISCOPAL type of Church Organization and there is no over-ruling, ecclesiastical superstructure. There may be elected boards and committees who serve to facilitate cooperation among local organizations, but these are wholly executive in nature, carrying out the instructions of the Apostle, Bishop, or General Overseer.

Section 2- Duties and Powers. The Executive Director shall be responsible for the control and management together with the President. The Board of Directors constitutes the supreme executive, legislative and judicial authority of Gateway Community Outreach Church, Inc. Whatever actions doings or rulings which it makes is not subject to review or reversal by any other agency or authority in the church. The three Board of Directors shall manage all affairs, property, and interests of the Corporation and may exercise all powers of the Corporation, except as limited by statue.

Section 3- Duties of officers. Officers of the Corporation shall, unless otherwise provided by the Board, each have such powers and duties as generally pertain to them respective officers as well as such powers and duties as may from time to time be specifically decided by the Board. The Executive Director / Apostle Andrew J. Jones shall be the Chief Executive Officers of the Corporations. Amended May 5, 2022

Section 3 - Executive Director / CEO— Shall be the principal executive officer of the corporation and to oversee and have control of the Board of Directors, it shall in general oversee, and supervise and control all legal lawful business and all day-to-day business affairs of the Corporation. They shall when present, preside at all meeting of the Board of Directors. He may sign with the secretary or any other officers of the corporation, For certificates, deeds, mortgages, bond, contracts, or other instruments that the Board of Director has authorized to be executed. In the absence of the Executive Director / CEO or in the event of his death, or refusal to act the President shall perform the duties of the Executive Director
