## ARTICLES OF INCORPORATION OF

## **NURTURING ARMS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following articles of incorporation ≥ ♀ ♀ ♀

III.

The purposes for which the Corporation is formed are the following:

Exclusively charitable with the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any further United States Internal Revenue law. This corporation is formed for the purpose of providing residential services for mentally challenged adults. Services include but are not limited to programs specifically designed for mentally retarded, developmentally disabled, and mentally ill consumers. Nurturing Arms, Inc. will develop a residential facility for low-income individuals, homes for the elderly, and fartily service center to foster health related services which include: alcohol/drug abuse, tobacco avoidance, life skills training, remedial and tutorial assistance. and other consumer and family support services. The corporation has a continuum of care for adults and their families which includes: referrals for psychological support services, family counseling, residential care. and comprehensive counseling services. This ongoing effort is the catalyst to empower individuals and families and bring them up to their maximum level of family functioning, bonding and awareness.

All programs created by Nurturing Arms, Inc. are designed to foster healthy living and lifestyles, improved or sustained quality of life, and to decrease the incidents of institutionalization, homelessness, and poverty.

- B. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- C. No party of the net earnings of Nurturing Arms, Inc. shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of Nurturing Arms, Inc. shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- D. In the event of dissolution, the residual assets of the organization will be turned over to a supporting organization, which themselves are exempt as organizations described in Sections 501 (c)(3) and 170 (C) (2) of the Internal Revenue code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or the Federal, State, or local government for exclusive public purpose.

**Nurturing Arms, Inc.** will engage in any other lawful activities whatsoever that are necessary, incident, or convenient to the carrying on of such activities or are intended to promote, directly or indirectly, such interest of the Corporation, and to exercise any and all powers that it might now or hereafter be lawful for the Corporation Code or any act amendatory thereof or supplemental thereto that may now or hereafter be enforce.
