

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I – Name

BCI Faith Based Dorm, Inc

ARTICLE II – Principal Place of Business and Mailing Address:

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III – Purpose

The specific purposes for which the corporation is organized is for conducting a "faith based dorm" program at Brevard Correctional Institute, a Florida Correctional facility. This dormitory will be sponsored by area churches, organizations and individuals.

It ALSO recognizes the Lordship of Jesus Christ, the ministry and gifts of the Holy Spirit and the priority of worshipping God in spirit and in truth. It shall have all the authority permitted for not for profit organizations to engage in any or all lawful activities permitted under the laws of the United States of America, the State of Florida, or any other state, country, territory or nation.

ARTICLE IV – Manner of Election of Directors

The affairs of the corporation shall be managed by a Board of Directors. The Board shall have the power to admit members of the corporation in such manner, subject to such qualifications, and upon such terms and with such rights as may be provided from time to time by By-Laws of the corporation.

ARTICLE V – Limitation of corporate powers

The corporate powers of the corporation are as provided in section 617.0302, Florida Statutes.

ARTICLE VI – Initial registered agent and street address:

ARTICLE VII – DISSOLUTION

Upon dissolution of the corporation, the board of directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation to another organization or organizations which are organized and operated for the same purposes for which this corporation is organized or to such organization or organizations, organized and operated exclusively for charitable, educational, religious, literacy or scientific purpose as shall at the time qualify as an exempt organization or organization under section 501C3 of Internal Revenue code of 1954 as amended. As the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the

County in which the purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX

The members of this corporation shall have no rights, title or interest whatsoever in its income, property or assets, nor shall any portion of such income, property, or assets be distributed to any member on the dissolution or winding up of this corporation. Members of this corporation shall not be personally liable for the debts, liabilities or obligations of the corporation and shall not be subject to any assessments.


