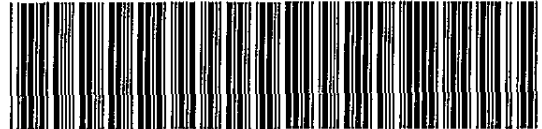

**ARTICLES OF NON-PROFIT INCORPORATION
OF
BRIDGE BUILDERS ENTERPRISES, INC.**

ARTICLE I - NAME

The name of this non-profit corporation is **BRIDGE BUILDERS ENTERPRISES**
INC.

ARTICLE II - DURATION

This non-profit corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This non-profit corporation is organized for the purpose of transacting any or all lawful business as a not for profit organization to wit: (i) to develop community based programs that promote the social welfare of disadvantaged children commonly referred to as "children at risk"; (ii) to develop community based programs that combat juvenile delinquency; (iii) to develop community based programs that promote social welfare for teenage mothers and educational advocacy for abstinence during teenage years; (iv) to develop community based programs that advocate HIV awareness and prevention and other health issues that commonly effect the minority communities of Florida; (v) to develop community based programs that promote social welfare for the homeless and such other programs that will help bring about a better Florida community by addressing minority community needs through a variety of diverse community based programs.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE V - INITIAL BOARD OF DIRECTORS

This corporation shall have four directors constituting the initial Board of Directors. ARTICLE VII - INDEMNIFICATION

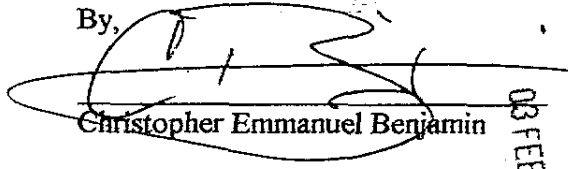
The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.
