ARTICLES OF INCORPORATION

OF

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation under Florida Not for Profit Corporation Act, and hereby adopts the following Articles of Incorporation.

ARTICLE I – NAME

The name of this corporation shall be **BRAULIO ALONSO HIGH SCHOOL BOOSTER CLUB, INC.**

ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III – PURPOSE

ARTICLE V – REGISTERED OFFICE AND REGISTERED AGENT




