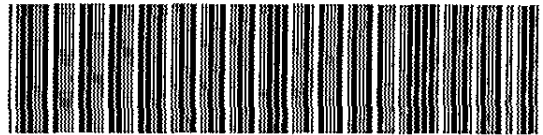



ARTICLES OF INCORPORATION  
of  
**GOD'S ANOINTED DELIVERANCE MINISTRY, INC.**

SECRETARY OF STATE  
TALLAHASSEE FLORIDA

The undersigned, acting as incorporator of a Corporation for the purpose of forming a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation.

**ARTICLE I - Name.** The name of the corporation is **GOD'S ANOINTED DELIVERANCE MINISTRY, INC.**

**ARTICLE II - Register Agent.** The registered agent of this corporation shall be WILLIAM J. BOYD, 391 W. Griffith Avenue, Crestview, Florida 32536.

**ARTICLE III - The Purpose.** The purpose for which this corporation is formed is for non-profit religious ministry. The corporation will be able to do all things necessary, suitable or proper for the accomplishment of the purposes aforesaid including particularly, but by such inclusion not intending any limitation, power to:

- a) To do all things necessary and proper to promote, maintain, build, and improve real or personal property; hire all necessary employees, to prescribe rules, regulations and terms of accommodation for said properties; to solicit funds, agreements, subscriptions, gifts, grants, deeds, bequests and legacies.
- b) Buy, own, hold, sell, lease, let, hire, take, mortgage and convey such real estate as is necessary or desirable for the purpose of said corporation.
- c) Buy, own, hold, sell, transfer, mortgage and otherwise convey or hypothecate any equipment supplies or other articles necessary or desirable in the conduct of said business.
- d) Contract any debt incidental to the conduct of said business.
- e) To accept, hold, and manage donations, gifts, grants, gifts, grants, gifts in trust, annuities, legacies, devices, or bequests from individuals, corporations, and institutions for the purposes of conducting or furthering said business, or for the purposes designated by the donor or settler consistent with the purposes of this corporation.,
- f) Do everything that is incidental, necessary or convenient to any of the purposes herein stated.
- g) The corporation shall have all powers set forth in Florida Statute §617.0302.

- h) The place where the principle business of this corporation shall be transacted in Okaloosa County and Crestview, Florida.

ARTICLE IV - Duration. The corporation shall have perpetual existence.

ARTICLE V - Incorporator. The name and address of the person signing these Articles is:

ARTICLE VI - Principal Office. The street address of the principal office of this corporation in this state is 194 Main Street, Crestview, Florida 32536.

ARTICLE VII - Initial Registered Office. The street address of the initial registered office of this corporation in this state is 391 W. Griffith Avenue, Crestview, Florida 32536.

ARTICLE VIII - Non-Profit Corporation. This corporation shall have no capital stock and shall be a non-profit corporation.

ARTICLE IX - Independent Corporation. This corporation shall not be subject to any superior body or bodies and shall be an independent corporation.

ARTICLE X - Appointment and Election of Directors. The number of directors of this corporation shall be five (5). The term of office for the corporate directors shall be five (5) years, except for initial term where the president shall serve for five (5) years, the vice president shall serve four (4) years, the secretary shall serve three (3) years, the treasurer shall serve for two (2) years and the assistant secretary shall serve an initial term of one (1) year. Each director shall be eligible for reappointment upon the expiration of their term of office. Vacancies of office shall be filled by appointment by the existing board.

ARTICLE XI - Amendment. These Articles may be amended in the manner provided by law.

ARTICLE XII - Dissolution. This corporation may hold all property, of any amount, coming into it's possession for the attainment of the object thereof. In case of dissolution of this corporation, the property and assets of this corporation shall transfer to the any charitable organization.
