ARTICLES OF INCORPORATION

OF

NORTHWEST DADE PROPERTY RIGHTS COALITION, INC. (A Florida Corporation Not for Profit)

ARTICLE I

Name

The name of this corporation is NORTHWEST DADE PROPERTY RIGHTS COALITION, INC. (the "Corporation").

ARTICLE II

Principal Office and Mailing Address

The address of the principal office of the Corporation shall be 18302 N.W. 122nd Avenue, Miami, Florida 33015, and the mailing address of the Corporation shall be P.O. Box 15065, West Palm Beach, Florida 33416.

ARTICLE III

Purpose

The Corporation is a not-for-profit corporation, organized to improve property values and preclude the diminution in property values in Northwest Miami-Dade County, Florida, and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit corporations may be organized, so far as is or may be permitted by the laws of the State of Florida.
