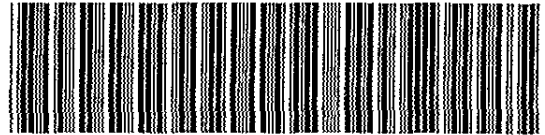

for
