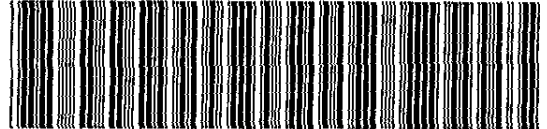

### **ARTICLE I NAME**

The purpose for which the corporation is organized is exclusively for charitable and educational purposes as stated within the meaning of Section 501(C) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(C) (3) of the Internal Revenue Code of 1986.




