ARTICLES OF INCORPORATION OF THE AMERICAN CANCER SOCIETY, BREVARD COUNTY, FLORIDA CHAPTER,

Articles of incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name shall be THE AMERICAN CANCER SOCIETY, BREVARD COUNTY, FLORIDA CHAPTER, INC.,

Second: The place in this state where the principal office of the Corporation is to be located is the City of 4155 Windover Way, Melbourne, Brevard County, FL.

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: The names and addresses of the persons who are the initial trustees of the corporation are as follows: Lori L. Conway, 4155 Windover Way, Melbourne, FL 32934; D. Danmont Ferrell 2190 Lake Side Ave., Melbourne, FL 32934; Paul Oliver, 642 Waycross Rd., Palm Bay, FL 32908.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.
