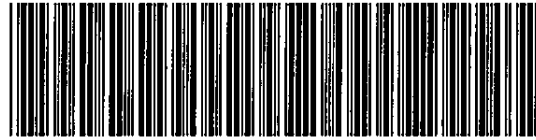

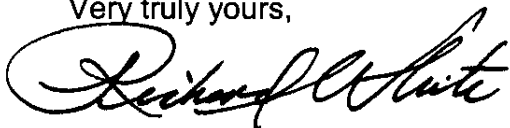

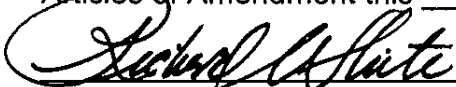
#### **ARTICLE VIII – EFFECTIVE DATE AND APPROVAL DATE**
