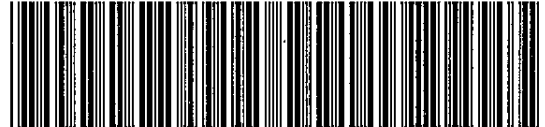

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBERS BEING AMENDED, ADDED OR DELETED.)

This shall amend Article V to be such that the highest amount of indebtedness or liability to which the corporation may at any time subject itself, shall be Two Hundred and Fifty Thousand (\$250,000.00) dollars, provided however, that the amount of such indebtedness or liability shall never be greater than two-thirds of the value of the property of the corporation.

This corporation may hold and own real estate and other property amounting in value to Four Hundred Thousand (\$400,000.00) Dollars subject always to the approval of one of the judges of the Circuit Court of the Fourth Judicial Circuit of the State of Florida.
