ARTICLE I NAME

The name of the corporation shall be **TERCIARIOS DE LOS SAGRADOS CORAZONES**, **INC** translated from Spanish to English as THIRD ORDER OF THE SACRED HEARTS, INC.

ARTICLE II PRINCIPAL ADDRESS

The principal place of worship for the organization shall be 2700 Glades Circle, Suite 110, Weston, Florida 33327.

ARTICLE III PURPOSE AND DURATION
