

**ARTICLES OF INCORPORATION
FOR
FEDERAL GARDENS NEIGHBORHOOD ASSOCIATION, INC.**

ONE: The name and address of the principal corporation is
FEDERAL GARDENS NEIGHBORHOOD ASSOCIATION,
INC, 1631 W. 14TH Street in Palm Beach County.

The corporation is organized pursuant to the Florida
Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation
and is not organized for the private gain of any person.
The corporation is organized under the Nonprofit Public
Benefit Corporation Law for charitable and educational
purposes to aid the poor and disadvantaged individuals
and families towards a life of self-sufficiency. The
program will consist of, but shall not be limited to:
Job Training, Job Placement, Employment, Land Acquisition,
Community Development, Community Redevelopment, Housing,
Temporary Shelter, Counseling, Teenage Pregnancy,
Substance Abuse Awareness and Prevention, Literacy,
Tutoring, AIDS, Elderly Care, Child Care, Performing Arts,
Literary Arts, Visual Arts, and other programs to aid those in
need.

THREE: The Duration of this corporation shall be perpetual,
and shall be operated on a non stock basis within the
meaning of the Florida Not For Profit Corporation Act,
and shall not have the power to issue shares of any type
or class of stock, and shall have no members.

FOUR: The address of the Registered office is: 1631 W. 14th Street, Riviera
Beach, FL 33404 in Palm Beach County, and the name of the
registered agent of the corporation shall be Ethel J. Reid.

FIVE:

- (a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)3 of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)3 of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

SIX:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

SEVEN: The Board of Directors shall have four (4) members whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

EIGHT: The officers of the Corporation shall consist of a President, Vice President, Secretary, and Treasurer. Officers may be provided for in the Bylaws. Each officer shall be nominated by a neighbor and voted upon by neighbors.






