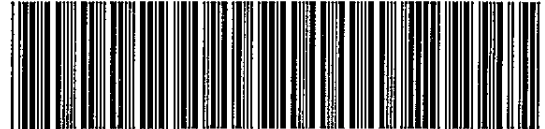

ARTICLE OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Article of Incorporation.

ARTICLE I- Name.

Light of the Lord Ministries, Inc, its principal place of business shall be 2123 Washington St. N.E. Palm Bay Fl 32905 and such other places within the state of Florida, as the Board of Directors shall from time to time designate.

ARTICLE II- Purpose

The purpose of the corporation shall be the following:

To provide care for the mentally ill, the addicted, the disabled and those who might otherwise die alone;

To assist all governmental agencies in pursuance of their endeavors as they concern rehabilitation of citizens;

To establish necessary relations with other organizations or functions to bring about benefit to this corporation;

To accept all person regardless of age, race, sex, religion or lack of religion who are in need of the facilities and guidance offered by this corporation;

To receive gifts, grants of money and property of every kind and to administer the same for charitable, educational, civil, and philanthropic uses and to do everything necessary or proper for the accomplishment of these purposes;

To engage in the acquiring by purchase, exchange, constructions or other means, and thereafter in owning, maintaining, and carrying on a institution, boarding home or other establishment suitable for the reception, care, treatment, rehabilitation and guidance of all persons young or elderly.

To purchase, or otherwise acquire, own, mortgage, pledge, sell, assign and transfer, or otherwise dispose of, to invest, trade, deal in and deal with good, wares, merchandise and real and personal property of every class and description

ARTICLE III. - USE OF INCOME

All revenue, profit, income and money received from the conduct of such business or enterprise is to be used and employed in the furtherance of the above noted purposes and not for the benefit of the members of said corporation, , either individually or collectively;

ARTICLE V- POWERS

Said corporation is to have the power to do any and all things necessary or expedient for the carrying out of the said objects and purposes of the corporation an in general to posses all rights, privileges and immunities, and enjoy all benefits granted to corporations of similar character under the law of the State of Florida.

ARTICLE V. TERM OF EXISTENCE

This corporation shall have perpetual existence

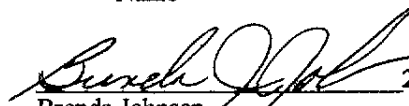
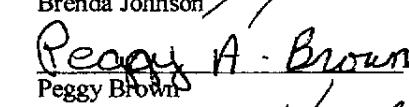

#### ARTICLE VII- BOARD OF DIRECTORS

#### ARTICLE VIII. OFFICERS

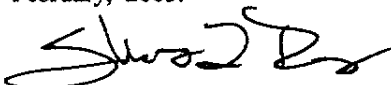
