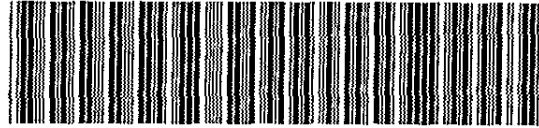

The undersign, acting as the incorporator of this corporation, hereby adopts the following Articles of the Incorporation as registered with the State of Florida

ARTICLE I: NAME

The name of the corporation shall be: FAMILIES AND YOUTH ENHANCEMENT, INC, hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPLE OFFICE AND MAILING ADDRESS

The address of the principle office and the mailing address of the Corporation is 3300 Inverrary Blvd., # 100D, Lauderhill, Florida 33319.

ARTICLE III: DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law, and shall have no stock.

ARTICLE IV: PURPOSES

The corporation has been organized to transact any and all lawful business for which corporations may be incorporated in this state.

ARTICLE V: BOARD OF DIRECTORS

The Board of Directors shall consist of three (3) persons. The number of directors may be increased or decreased from time to time by amendment to the by laws; however, there shall never be less than three (3) directors. All directors shall be selected as provided for in the bylaws.

ARTICLE VIII: AMENDMENTS

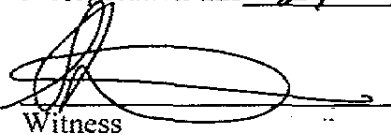

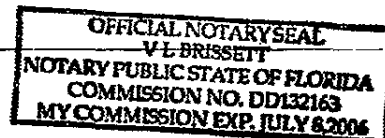
