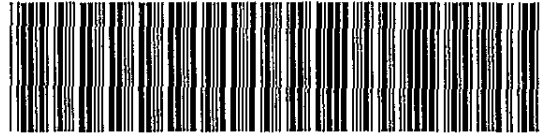

ARTICLE I: NAME

The name of the corporation shall be **IMPACT N.O.W., INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III: PURPOSE

IMPACT N.O.W., INC. shall be a non-profit corporation and is organized exclusively for charitable, educational and scientific purposes under section 501(c)(3) of the Internal Revenue Code. **IMPACT N.O. INC.** will provide services as a community development corporation, services including, but not limited to, distribute food and clothing; provide counseling and tutorial services for the youth; provide referral service for vocational training; provide resources and information for social awareness; and provide educational awareness on economic and environmental issues.

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign or behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE IV: APPOINTMENT OF BOARD OF DIRECTORS

The Board of Directors shall be appointed by the Incorporator of **IMPACT N.O.W., INC.**
