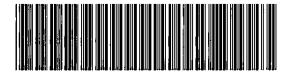

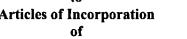

ARTICLE I NAME

The name of the corporation shall be Garden of Hope: Victory Outreach Ministries Inc.

<u>ARTICLE II PRINCIPAL OFFICE</u>

The principal <u>street</u> address 3508 Roselawn Blvd. Fort Pierce, Florida 34982 The mailing address is 3508 Roselawn Blvd. Fort Pierce, Florida 34982

ARTICLE III PURPOSE

The general nature and purpose of this corporation is to own, purchase, hold, manage, lease, mortgage, pledge, acquire by gift, devise purchase or otherwise, erect, construct, provide for, maintain and equip suitable buildings, churches houses, authorize and manage financial accounts and otherwise handle and dispose of such real estate and personal property as shall be authorized and directed by the unincorporated body of said Garden of Hope: Victory Outreach Ministries Inc. of Fort Pierce, Florida a "Christian" Corporation.

This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the Florida Nonprofit Religious Corporation Law exclusively for religious purposes. The specific purpose for which this corporation is organized are religious ones including to witness to a Nation, to proclaim Christ, to bring people into right relationship to Christ, to take Christ into the world, to restore the body of Christ, to provide a place for public worship, religious training and education, basic human needs, to teach, preach, and prophesy the word of Jesus, and to restore faith, family, friends, and finance.

This corporation is organized exclusively for charitable, educational, scientific, and religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax codes). This corporation is organized and operated exclusively for non-profit purposes.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a

corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed: The Directors shall be elected by a majority vote of the Members of said **Garden of Hope: Victory Outreach Ministries Inc.** The corporation shall be governed by a board of directors comprised of seven persons who shall serve as such until the initial annual meeting of the board of directors. Within one (1) year from the date of incorporation, a number of directors to be provided for in the bylaws shall be elected by a majority vote of the initial board of directors. Each director shall serve for a term of one year or until such time as his successor is determined. A director may be reelected for more than one term.
