ARTICLES OF INCORPORATION

OF

TOOL BAY HUNTING CLUB, INC.

(A non-profit corporation)

The undersigned subscribes to these Articles of Incorporation, each a natural operson competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I: NAME AND ADDRESS

The name of the corporation shall be TOOL BAY HUNTING CLUB, INC., and its principal place of business address shall be Hines Highway, Mayo, Florida 32066; and its mailing address shall be Post Office Box 257, Mayo, Florida 32066.

ARTICLE II: PURPOSE

The purposes for which the corporation is organized is that much of Lafayette County, Florida, is comprised of large timber tracts which offer excellent hunting. In order to limit their liability and enhance the hunting experience, the landowners have required that hunters using the property belong to an organized club. The Tool Bay Hunting Club, Inc., was formed to enable its members to pool their resources to lease a large tract of land for hunting purposes. The club leases a tract of land which is restricted for hunting purposes to members of the club. The members hunt wild game such as deer, turkey, hogs, etc.

ARTICLE III: MEMBERSHIP

The membership of this corporation shall be comprised of all persons herein as subscribers, directors and officers to these Articles of Incorporation, and membership in the corporation shall at all times be open to other persons who shall be interested in the furtherance of the purposes of the corporation. The conditions and regulations of membership and the rights and other privileges of the classes of membership shall be determined and fixed by the By-laws of this corporation.

The manner of admission to membership shall be upon invitation and paying dues.

ARTICLE IV: TERM OF EXISTENCE

This corporation shall commence existence upon the date of filing with the Division of Corporations, State of Florida. The corporation shall have perpetual existence.

When approved by a two-thirds vote of the membership present at such meeting, the said changes, alterations or amendments to the Articles of Incorporation must also be forwarded to the Secretary of State and filed and approved by that office before same shall become effective.

ARTICLE VIII: NON-STOCK CORPORATION

The corporation shall be non-stock and no dividends, net earnings, or pecuniary profits shall be declared, distributed to or inured to the benefit of any member, director or officer of this corporation.
