AMENDED ARTICLES OF INCORPORATION
FOR
PRAISE & WORSHIP INTERNATIONAL PROPHETIC MINISTRIES INC.

AMENDED ARTICLE III PURPOSES

PRAISE & WORSHIP INTERNATIONAL PROPHETIC MINISTRIES INC., DOCUMENT #N03000001981, shall provide spiritual place of worship for anyone who desires a deeper walk and personal relationship with our Lord and Savior Jesus Christ, Praise and worship Prophetic Ministries Inc., This corporation is organized exclusively for charitable, educational, religious or Scientific purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax codes).

This corporation is organized and operated exclusively for non-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer. Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future tax code). Articles of Incorporation Amended.

AMENDED ARTICLE III – I- CONFLICT OF INTEREST POLICY

In connection with any actual or possible conflict of interest, PRAISE & WORSHIP INTERNATIONAL PROPHETIC MINISTRIES INC., is to protect this tax-exempt organization's interest when it is contemplating entering into a transaction or arrangement that might benefit the private interest of an officer or director of the Organization or might result in the possible excess benefit transaction. This policy is intended to supplement not replace any applicable state and federal laws governing conflict of interest applicable to nonprofit and charitable organizations.

AMENDED ARTICLE III – J- DISSOLUTION

Upon dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.
