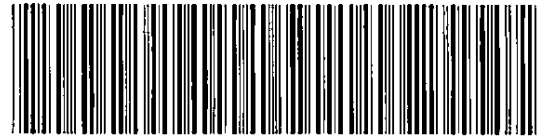


ARTICLES OF DISSOLUTION

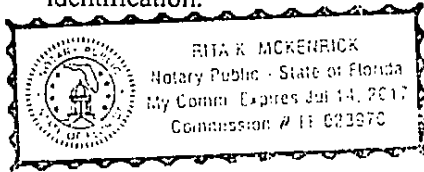


