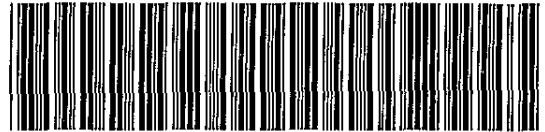

ONE: NAME AND ADDRESS

The name and address of this principal corporation is **Keiondra's Childcare Services, Inc. 3300 NW 172nd Terr. Miami, Florida 33056**. The corporation is organized pursuant to the **FLORIDA** non-profit Corporation Code.

TWO: PURPOSE


This corporation is a private, faith based, nonprofit Public Benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for scientific, literary, charitable and educational purposes. The organization provides 24 hour childcare services to median to low income families. The programs will consist of, but shall not be limited to childcare for children ages 0 to 5 and before / after school services, for youths ages 5 to 12.

THREE: DURATION

The duration of this corporation shall be perpetual, no stock and shall have no members.

- b) Notwithstanding any other provision of these Articles, the corporation Shall not carry on any other activities not permitted to carry on (1) by a Corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

EIGHT:

DISSOLUTION OF CORPORATION

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Charitable and Education under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax codes, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
