ARTICLES OF INCORPORATION OF

Family Health Counseling Center, Inc.

The undersigned incorporator, for the purpose of forming a corporation pursuant to chapter 617, Florida Statutes, Adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: Family Health Counseling Center, Inc.

ARTICLE II- PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

West Palm Beach, FL 33406

ARTICLE III- PURPOSE OF ORGANIZATION

The corporation has been organized exclusively for charitable purposes, within the meaning of section 501 (c) (3) of the Internal Revenue Code. The purpose of this organization is for treatment to the general public with a strong emphasis on indigent care for the purposes of intervention, prevention, and therapy for substance abuse, driving under the influence, and domestic assault.

ARTICLE IV- MANNER OF ELECTION OF DIRECTORS

All directors will be duly appointed by the President

ARTICLE V- LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes without limitation.

ARTICLE VI- INITIAL REGISTERED AGENT AND ADDRESS

ARTICE VII- NOT FOR PROFIT PROVSIONS

No part of the net earnings of the corporation/organization shall inure to the benefit of, or be distributable to its' members, trustees, directors, officers, or other private persons, except that the corporation/organization shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions in

furtherance of section 501 (c) (3) purposes. No substantial part of the activities of the corporation/organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from Federal income tax under section 501 (c) (3) of the contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

ARTICLE VIII- TERM OF EXISTENCE

The corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE IX- DISSOLUTION OF TERMS

Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes withing the meaning of Section 501 (c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

ARTICLE X- NUMBER OF DIRECTORS

The corporation shall have three (3) Directors initially. The number of Directors may be increased or diminished from time to time by the By-Laws, but shall never be less than (3). The Directors namely being:

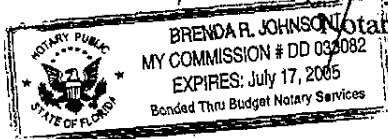
