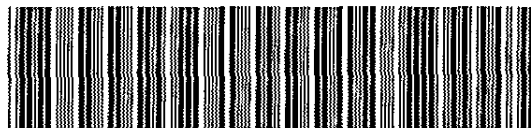

ARTICLES OF INCORPORATION HEART FOR CHRIST FELLOWSHIP, INC.

2003 MAR -7 PM 3:51

Articles of Incorporation of the undersigned, a majority of who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, chapter 617; do hereby certify:

DEPT. OF STATE
TALLAHASSEE FLORIDA

First: The name of the corporation shall be: Heart For Christ Fellowship, Inc.

Second: The place in this state where the principal office of the Corporation is to be located is the city of Winter Springs, Seminole County.

Third: Said corporation is organized exclusively to provide religious worship and education, churches, schools, missions and other institutions connected therewith of a religious, educational, charitable and benevolent character to the end that people may be generally guided and instructed concerning these articles of faith which are to advance spiritual growth and enlightenment, moral and personal purity among people; To promote home and foreign missions; and to aid in the spread of the Gospel of JESUS CHRIST. Formed under section 501(c)(3) of the Internal Revenue Code.

Fourth: The names and addresses of the persons who are the initial trustees of the corporation are as follows:

Sixth: The incorporators shall be the names and addresses of the subscribers of these Articles of Incorporation as listed in article fourth above.

Seventh: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third above. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Eighth: Upon the dissolution of the corporation, the board of directors, shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all remaining assets to one or more organizations qualifying for exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the correspondent section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

Ninth: Qualifications for membership in the corporation and to the Board of Directors are as stated in the By-Laws. Directors shall be elected in accordance with the By-Laws. (ENCLOSED)
