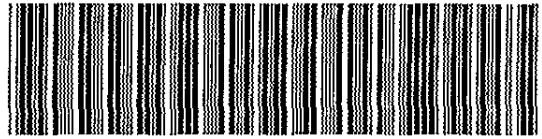

ARTICLE I

Name
