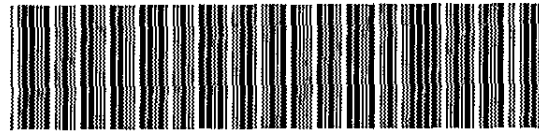

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: the Minority Alliance for Advocating Community Awareness and Action Inc.,




