ARTICLES OF INCORPORATION OF

P. OWER F. ROM O. N. H. IGH MINISTRIES, INC. A FLORIDA NON-PROFIT CORPORATION

Article of incorporation of the undersigned, desiring to form an Church under the non profit corporation law of chapter 617, Florida Statues, do hereby certify.

ARTICLE 1- NAME

The name of the corporation is **P.**ower **F**.rom **O**.n **H**.igh Ministries, Inc.,

ARTICLE 2 – DURATION

The period of its duration is perpetual, unless dissolved according to law. P. ower F. rom O.n H. igh Ministries, Inc., existence shall commence upon March 7, 2003.

ARTICLE 3 - PURPOSE(S) OF CORPORATION

The purpose for which P.ower F.rom O.n H.igh Ministries, Inc. is organized is as follows:

PURPOSE (1) To establish this central and principal Church and such other affiliate outreach ministries to be sanctioned by the principal Church throughout the United States of America and the territories thereof, and also throughout the universe, wherein and whereby the Glory of God, His son Jesus Christ, and the Holy Ghost may be extolled, reverenced, and proclaimed, in accordance with the tenets of worship discipline, rules, regulations, rituals, ceremonies, and practices which are now being, or from time to time hereafter may be followed.

PURPOSE (2) to inculcate and disseminate religious knowledge in conformity with the tenets of worship, discipline, rules, regulations, designated, formulated, promulgated, and established by the Board of Directors of the said principal Church: City of Plantation, County of Broward.

PURPOSE (3) To establish and maintain Outreach Ministries to help and work with the homeless; conduct services and fellowship with inmates in the correctional institutions; to deliver food to the sick and shut-ins; to visit men and women in the inner city convalescent homes to share a message of hope, comfort, and joy through music, singing, and encouragement. Members of P.ower F.rom O.n H.igh Ministries, so as to qualify for themselves for ordination as ministers of P.ower F.rom O.n H.igh Ministries, subject to the approval as to fitness for said ministry by the Board of Directors who shall constitute the sole and exclusive examining Board and whose decisions regarding qualifications and fitness of those to receive ordination as ministers shall be final.

PURPOSE (4) to establish, maintain and otherwise operate orphanages, homes for the aged, homes for the homeless, day care centers and all other facilities necessary to aid the general public.

PURPOSE (5) to establish an Adopt-A-Community Outreach Ministry, to create work for homeless and disenfranchised men and women. The men will travel to surrounding communities to remove any overgrowth or accumulation of grass or weed, junk and trash from improved or unimproved lots, and create other type of jobs for the women.

PURPOSE (6) to secure, plan layout, improve and maintain land to be used for the purpose of holding religious camp meetings, reunions and gatherings for the said members of said principal Church and affiliate ministries.

PURPOSE (7) To have and to hold and to possess real and personal property either by purchase, leased or gift, to be used and employed for the purpose and objects of said corporate body, to mortgage and sell property and to contact for the reactions of center building, for all other matters deemed advisable to promote and extend the functions and activities of the said body.

PURPOSE (8) to publish an inspirational magazine, spreading the Gospel through a collective body of Pastors, Evangelists, Ministers, and Leaders writing descriptive articles to encourage the general public to persevere through their daily trials and tribulations.

PURPOSE (9) The Corporation is not organized for a private gain. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered. To make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of the corporation shall be the carry on of propaganda. Otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of or in opposition to any candidate for public office. Not withstanding any part of these articles.

This Corporation shall not carry on any other activities not permitted to carry on. (A) By a corporation exempt from federal income tax under Section 501(C) (3) of the Internal Revenue Code, or the corresponding section of any future federal income tax code. (B) By a corporation, contributions to which are deductible under Section 170(C) (2) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE 4 - CORPORATION DISSOLUTION

The Corporation Dissolution of Assets, upon the dissolution or winding up of this corporation, its assets remaining after payment or provision for payment of all debts and liabilities of the corporation, shall be disposed of by the court of common plans of the county in which the principle office of the corporation is then located, exclusively to religious and charitable purpose organizations, as said court shall determine, which has established its tax exemption status under Section 501(C)(2) and 170(C)(2) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

ARTICLE 5 - PRINCIPAL OFFICE

ARTICLE 9 - CAPITAL STOCK

P.ower **F.**rom **O**, n **H.**igh Ministries shall have no capital stock and shall be composed of members rather than shareholders.

ARTICLE 10 - QUALIFICATIONS OF MEMBERSHIP

The categories of membership, qualifications for membership and manner of admission shall be as set forth in and regulated by the By Laws of **P.**ower **F.**rom **O.**n **H.**igh Ministries.

ARTICLE 11 - VOTING RIGHTS

Members of *P.ower F.rom O.n H.igh Ministries* will have such voting rights as are provided in the By Laws of *P.ower F.rom O.n H.igh Ministries*.

ARTICLE 12 – LIABILITIES FOR DEBTS

Neither the members nor the members of the Board of Directors or officers of *P.ower F.rom O.n H.igh Ministries* shall be liable for the debts of *P.ower F.rom O.n H.igh Ministries*.

ARTICLE 13 - REGISTERED OFFICE AND REGISTERED AGENT
