# ARTICLES OF INCORPORATION

## IRGUN HASHOMERIM INC. A NON PROFIT CORPORATION

### 1. Corporation Created

The following persons, to wit:

Ms. Joy Deanne Langgle of Miami Beach, FL  
Mr. Michael Aaron Gayon of Miami Beach, FL  
Mr. Yisrael Ben-Yahuda of Tel Aviv Israel

And their associates and successors, are incorporated and declared to be a body corporate by the name Irgun Hashomerim Inc. (herein referred to as the corporation)

### 2. Objects and Purposes

The objects and purposes of the corporation shall be as follows...

A.) To provide an organization to encourage, empower and aid all persons economically disadvantaged as defined by the constitution and by laws of the corporation, regardless of race, sex, religion, color or nation of origin in becoming educated, employed and to assist them in bettering themselves as active, productive and vital members of society.

B.) To provide an organization to act as a re-entry or entry step for all Jewish persons cut off from their heritage by providing classes in Hebrew, Torah, the laws and precepts of Jewish living.

C.) To protect, assist and aid all persons from persecution based on age, skin color, nation of origin, religious beliefs or heritage.

D.) To provide education and training to it's members and to any other person to encourage and foster it's programs and provide facilities to assist in meeting its corporate goals.

E.) To support the state of Israel in all ways as outlined in the bylaws and constitution of the corporation.

### 3. Membership

Eligibility for membership in the corporation and the rights and privileges of members shall be determined according to the constitution and bylaws of the corporation.

#### 4. Prohibition against issuance of stock; completion of organization

A.) The corporation shall have no power to issue capital stock being that it is solely an organization of benevolent character and not for unusual pecuniary gain of its members as specified by the constitution and bylaws of the corporation.

B.) The persons named in Section 1 of the Articles, their associates, and successors are authorized to complete the organization of the corporation by the election of officers (in a bi annual general election by majority vote of all members) , the adoption of a constitution and bylaws, the promulgation of rules and regulations that may be necessary for the accomplishment of the purposes of this corporation, and the doing of such other acts as must be necessary for such purposes.

#### 5. Powers of Corporation

The corporation shall have perpetual succession and power-

A.) To sue and be sued.

B.) To acquire, hold, own, mortgage and dispose of such real and personal property as may be necessary for its corporate purposes.

C.) To accept gifts, legacies and devises which will further the corporate purposes.

D.) To adopt and alter a corporate seal.

E.) To adopt and alter a constitution, bylaws, rules and regulations, not inconsistent with the law.

F.) To establish and maintain offices, domiciles, shelters and homes for the conduct of the affairs of the corporation in the state of Florida and any other state or territory of the United States, Canada or Israel.

G.) To do any and all acts and things necessary and proper to carry into effect the objects and purposes of the corporation.

#### 6. Exclusive rights to name, insignia, uniforms, copyrights, emblems and badges

The corporation shall have the sole and exclusive rights to the names:

A.) Irgun Hashomerim Inc.

B.) Project Geshar

C.) Project Ahavat Israel

#### D.) Hashomerim Israel

And to have and to use, in carrying out its purposes, all insignia, uniforms, copyrights, emblems and badges, descriptive or designating marks or words and words or phrases, now or prior to February 17, 2003, used by the corporation in carrying out its mission: provided however, that no powers or privileges herein granted shall interfere or conflict with established or vested rights.

#### 7. Dissolution Clause

If for any reason and by unanimous vote of the Board of Directors this corporation is declared dissolved, all assets less those pledged for in any way by debt, contract, the constitution or bylaws of the corporation shall be transferred to the Aleph Institute at 9540 Collins Avenue, Surfside, FL 33140 and to be used by Aleph Institute in a manner as seen fit by its leadership.
