## ARTICLES OF INCORPORATION RIDGEWOOD AREA NEIGHBORHOOD ASSOCIATION, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation not-for-profit under Chapter 617 of the laws of the State of Florida.

## ARTICLE I -NAME

The name of this corporation is Ridgewood Area Neighborhood Association, Inc.

## ARTICLE II - LOCATION

The address of the principal office shall be the home address of the President.

ARTICLE III - PURPOSES

This Corporation is organized as a not-for-profit corporation under Chapter 617, Florida Statuţës, for the following purposes:

- 1. To preserve, protect, and enhance the beauty, safety and value of the property of the Ridgewood Area Neighborhood.
- 2. To take any action or formulate any policies that may be agreed upon as promotive of the Ridgewood Area Neighborhood as a good residential area of the city of Jacksonville.
- 3. To provide a link of communication between the neighborhood and city government.
- 4. To promote closer acquaintances and friendships among the residents of the Ridgewood Area Neighborhood and to promote social and recreational activities that may be agreed upon for better living in the city of Jacksonville.

This Corporation is organized and will be operated exclusively for charitable purposes as a not-for-profit corporation within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) (the "Code"), and its activities shall be conducted for such purposes in such a manner that no part of its net earnings shall inure to the benefit of any member, director, officer or individual except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes to exercise the powers permitted not-for-profit corporations under Chapter 617, Florida Statutes; provided, however, that the Corporation in exercising any one or more powers shall do so in furtherance of the exempt purpose for which it has been organized as described in Section 501(c)(3) of the Code or any amendments or additions thereto.

Notwithstanding any other provisions of these articles, this Corporation shall not carry on any activities not permitted to be carred on by (a) a corporation exempt from Federal income tax under Section 501(C)(3) of the Code or (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

## ARTICLE IV - ELECTION OF DIRECTORS

The property, affairs, business and operations of the Corporation shall be managed by a Board of Directors, which shall consist of not less than three directors who are elected by the membership. The directors are as follows:
