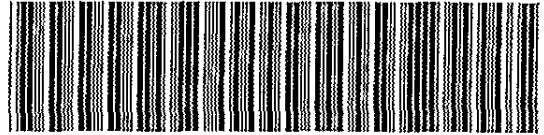

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

SCATTERED SITES RESIDENT COUNCIL, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

Our purpose is to develop a resident management program which participates in the administration, operation and management of public housing units in Jacksonville, Florida, including but not limited to Scattered Site housing, to benefit the residents of these public housing units or assistance housing and section (8) housing.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

Section 4. Voting. Any member of a public housing household residing in Scattered Sites whose name is on the lease and is eighteen (18) years or older is eligible to be a member of Scattered Sites resident Council, Inc., vote in Resident Council elections, and seek office and serve on the Resident Council Governing Board. Voting by proxy is not allowed.
