

**ARTICLES OF INCORPORATION  
OF  
FRIENDS OF THE GREEN SWAMP WATERSHED, INC.  
(In compliance with the requirements of F.S. Chapter 615)  
(Not for Profit)**

**ARTICLE I: NAME**

The name of the corporation ("Corporation") shall be **FRIENDS OF THE GREEN SWAMP WATERSHED, INC.**

**ARTICLE II: PRINCIPAL OFFICE**




