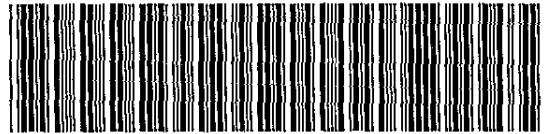



ARTICLE I – NAME

The name of this corporation is Kingdom of Glory, Inc

ARTICLE II – DURATION






