ARTICLES OF INCORPORATION OF AMERICAN HOMESAVERS, INC.

I, the undersigned incorporator, do make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a Corporation Not For Profit in accordance with the Laws of the State of Florida.

ARITCLE I - NAME

The name of this corporation is AMERICAN HOMESAVERS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and the mailing address of this corporation shall be: 909 Dennis Avenue, Orlando, FL 32807.
