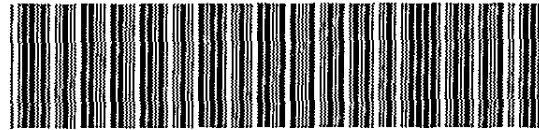

**ARTICLES OF INCORPORATION
OF
AMERICAN HOMESAVERS, INC.**

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

I, the undersigned incorporator, do make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a Corporation Not For Profit in accordance with the Laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is **AMERICAN HOMESAVERS, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and the mailing address of this corporation shall be: 909 Dennis Avenue, Orlando, FL 32807.

ARTICLE III - PURPOSE

This corporation is formed for the following purposes:

- a) To assist financially distressed homeowners in their attempts to save their homes from foreclosure,
- b) To have and exercise all of the rights, powers and privileges conferred or permitted by the Laws of the State of Florida.

In carrying out its purposes, the corporation may receive gifts and grants of money or property, invest and reinvest, collect income, and disburse funds to any person or organization, hypothecate its securities, issue bonds, execute promissory notes, mortgages and all manner of conveyances, and the property of this Corporation shall at all times be held, arranged and disposed of in accordance with the by-laws of the corporation.

ARTICLE IV - MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be provided for in the by-laws of the corporation.

ARTICLE V - POWERS

This Corporation shall have all powers provided for Corporations Not For Profit by Chapter 617, Florida Statutes, or any corresponding provisions of any subsequent statute.
