Formed pursuant to Chapter 617 of the Florida Statutes
As a Not For Profit Corporation

Article I – Name

The name of the corporation shall be GINOSKO Services, Incorporated.

Article II – Principal Place of Business

The principal place of business shall be 3908 SE 17th St., Ocala, Florida 34471. The corporation's principal office is located in Marion County, Florida. The mailing address shall be POB 6028, Ocala, Florida 34478.

Article III – Purpose

The purpose of the organization is as follows: To provide outreach ministry, prevention and intervention and transitional services to females; to move citizens toward self-sufficiency and professional development; to develop and implement programs that promote educational attainment and achievement for children, youth, and adults. The program will develop a faith-based ministry that will encompass volunteerism, intergenerational programming, and community service projects.

Article IV – Manner of Election

The property, business and affairs of the corporation shall be through a Board of Directors. The Executive Director initially will appoint directors. After a two year term a nominating committee made up of current directors will submit names before the Board for consideration to serve on the Board. Upon review, individuals will be voted upon unanimously to serve a two-year term on the Board. Should a Board member resign or be terminated for just call. The same process will occur with the nominating committee recommended a community person with similar interest to serve on the board.



