- I. The Board of Directors shall consist of 3 members and a Chairman. The Chairman will conduct the meetings. All Board Members will be appointed with 5 year terms. The Chairman will appoint new board members.
- II. The general purpose of The Royal Gorge Hunting Club will be to provide its club members with hunting on leased lands and to generate a quality hunting environment.
- III. A club year shall be considered the date from one annual club meeting until the following annual club meeting.
- IV. The Chairman will keep the meeting minutes and be custodian of all records.
- V. The Royal Gorge Hunting Club shall have no policy concerning the exclusion of any person in regards to sex, race, or religion.
- VI. The Board of Directors shall establish procedures for identification, key issuance, and key redemption.
- VII. Members shall abide by the agreement negotiated with all adjacent landowners and other clubs for the privilege of its members for trespass in and upon their land for the purpose of retrieving any hunting dogs of said members which may have entered in or upon such land while in the process of legally and lawfully hunting on club property.
- VIII. Any member who willfully and unlawfully violates any rule or bylaw will be contacted by the Chairman of the Board that his/her membership is canceled.
