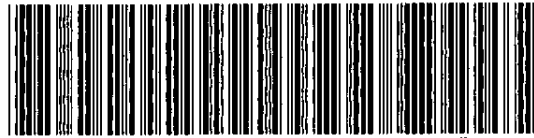

**PLAN OF DISTRIBUTION OF ASSETS

The Board of Directors in meeting on May 15, 2011 by a vote of 3 to 0 approved the following Plan of Distribution of Assets upon dissolution of the corporation:

1. All obligations and liabilities of the corporation shall be paid and discharged or adequate provisions be made therefore.
2. There are no assets held by the corporation requiring return, transfer or conveyance by reason of dissolution.
3. There are no assets held by the corporation limiting their use only for charitable, religious, eleemosynary, benevolent, educational or similar purposes.
4. The corporation has no assets required to be distributed to members or others.
5. The remaining assets of the corporation, as shown on Exhibit A hereto and which are valued at \$17,000, are to be transferred to Rita Crockett Academy, LLC in exchange for Rita Crockett Academy and its principal assuming the corporation's \$20,000 indebtedness to Capital City National Bank.
6. 6. Any remaining assets at dissolution will be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or to the federal, state or local government, for a public purpose.
